## Days and Hours of Operation

### Program Hours

The YMCA After School Program operates Monday through Friday in accordance with your ISD's calendar. Care is provided on early dismissal days. All programs run from the end of the school day to 6:30 p.m. Late fees will incur after 6:30pm (\$1/minute after 6:30pm). Please refer to the billing section of this guide for fee information.



### Fun Club

All day care is provided as an option on designated school holidays. Fun Club is NOT included in your After School fees. A sign-up form and fees will have to be submitted for care for these days. Fun Club hours are from 7:00am and 6:30pm and are held at multiple Elementaries in FISSD, Prosper ISD and Plano Legacy YMCA. Spaces are limited. Please refer to the Fun Club form for dates, locations, registration deadlines and fees. **Please remember to provide your child with a sack lunch on Fun Club dates.**

## Adventures in Math and Science A.I.M.S

AIMS is a non-profit organization dedicated to enriching, teaching, and learning through “Activities Integrating Mathematics and Science.” Designed by teachers for teachers, AIMS activities and curricula are extensively field tested and aligned with key math and science standards, including many state standards. Teachers and students in more than 40,000 schools have seen their understanding of math and science soar by using AIMS hands-on investigations.

## Great Explorations in Math and Science G.E.M.S.

GEMS is a hands-on science enrichment program. Science content reflects life and science as an inquiry. Subject matter and learning goals are taken from the National Education Standards. There is a strong emphasis on cooperative learning, problem solving, literature connections, and real world relevance.

“ Students enrolled in the new, hands-on programs scored an average of 20 percentile points higher on science process tests than students in conventional programs” (Bredderman)

## Kidz Lit

Kidz Lit is an all encompassing reading program. The goal is to bring good books to life. A variety of curricular components are integrated to encourage children to think and apply knowledge. Art, drama, music, writing, discussions, and games reinforce and expand upon a child’s existing skill level. With Kidz Lit, children get excited about books.

# General Program Information

## Licensing

The YMCA After School Program will abide by all standards regarding child care prescribed by the Texas Department of Family and Protective Services and by the YMCA of Metropolitan Dallas. **In order to attain full compliance with these standards, parents must complete all enrollment forms thoroughly and provide new information promptly as changes occur during the year or children will be dropped from the program.** You may contact licensing by calling 214-951-7902, or by going to their website [www.tdprs.state.tx.us](http://www.tdprs.state.tx.us).

## Absences

If your child is absent from the After School Program, please notify the YMCA staff before 12:00 p.m. on the school sites phone. Be sure to give your name, child's full name, your drivers license number, and which school they attend. **A \$3 charge will be assessed if no notification of an absent child is given. A \$5 charge will be assessed if your child is on a bus route. If your child attends a FISD, LEISD, CISD or a Prosper ISD after school program, please contact your child's site on the site phone. If your child attends a Plano ISD school please contact the Russell Creek or Plano YMCA in Legacy absence lines.**

## Snacks

Individually wrapped snacks are provided for your child daily.

## Personal Belongings

Remember to label all items brought to the program. Encourage your child to be responsible for their belongings. **The YMCA cannot be responsible for lost items. We suggest leaving all personnel items at home.**

## Sign In/Out

All children are expected to check in with the YMCA staff no later than 10 minutes after the school's release bell. Parents must sign their child/ren in and out every day with their full signature, not just initials. **Children who do not abide by this policy are subject to dismissal from the program. Drivers License numbers and Names must be on file before a child is released. If your child is participating in extracurricular activities after school (example: tutoring) a note detailing the time and days of these activities is needed.**

## Procedures for Release of Children

Children will only be released to the parents if their driver's license number is on file. **If someone else will be picking up your child, you must notify the staff by site phone. You will need to give your name, your driver's license, the name of the person picking up your child, and their driver's license number.**

## Procedures for Release of Children

All emergency contacts and parents will need to show proof of identification. **If being released to a minor, the minor must have a YMCA notarized form filled out by the parent on file, along with proof of identification. A minor must be at least thirteen years of age.**

## Illness and Exclusion Criteria

If a child becomes ill at the program, his/her counselor will notify the parent. Children who are ill must be picked up immediately and be kept at home until they have recovered. A child must be fever free for twenty-four hours before returning back to the program. If a child develops a contagious disease, please inform us immediately. Refer to page 10 of the ASP Parent Handbook.

## Medication Policy

## Procedures for Handling Medical Emergencies

In the event of a medical emergency, the Program Director will be notified, as well as the parents. A certified person will give First Aid immediately. In most cases, the injured person should not be moved. If more than First Aid is needed, the staff will call 911. In the event that the parent or guardian cannot be reached, the employee having immediate supervision should check parent's emergency authorization for instructions on treatment of child. If the child needs to go to the hospital, staff will take the health history and emergency authorization with the child to the hospital or send it with the paramedics. A YMCA Staff member will accompany the injured child to the hospital. After the immediate emergency has passed, a written statement and the proper After School forms will be filled out.

## Staff Statistics

All members of our skilled staff meet all YMCA qualifications. Each Staff member is certified in CPR, First Aid, and Blood Borne Pathogens. Staff members are at least 18 year of age with the exception of 16—17 year olds in a co-op program. Criminal background checks along with reference checks are conducted. YMCA staff members attend 30-50 hours of after school training a year. All staff must sign the YMCA code of ethics and are subject to random drug testing.

## Supervision

Staff will never leave a child unsupervised. Each YMCA After school site will hold a 1 to 15 ratio at all times.

### Outside Fraternalization

Staff will not fraternize with YMCA children outside the programs, including baby-sitting or inviting children home.

### Release to a Minor

A Child 13 years of age or older may pick up your child from care with a valid Government issued ID and minor to release form signed and notarized and turned in to the YMCA.

### Ozone Alert Days/Rainy Days

During Ozone Alert days or rainy days the children will be involved in indoor activities. This precaution is for your child's safety as well as the staff.

### Items Not to Bring to After School

These items are not to be brought to the program: toys, jewelry, video games, radio, money, knives, or any type of weapons. The YMCA is not responsible for any lost, broken, or stolen items. **If these items are brought to the program they may be confiscated and returned to the parent at the end of the day and disciplinary action may be taken.**

### Transportation

The After School Program will only be transported from a location due to bus routes, in the event of an emergency, or if your child is attending the full week Fun Clubs (Winter Break & Spring Break).

### Procedures for Parents to participate in the Child-Care Center 's

#### Operation and Activities

Parents must notify the Program Coordinator and/or Director at least forty-eight hours in advance. Parents must adhere to the Policies and Procedures set forth by the YMCA of Metropolitan Dallas.

### Procedures for Parents to Review a copy of the minimum standards and the child-care center 's most recent Licensing inspection report

All licensing reports are kept on site. Parents may look at a copy of the minimum standards and site's more recent Licensing inspection report at any time during the normal hours of operation.

Conferences will be held as necessary. If a child has a specific need or problem, the parents will be notified and the conference will be scheduled. Parents may request a conference if they feel a need to discuss their child's progress. All conferences are confidential.

# **PROGRAM PARTICIPANT AND MEMBER BEHAVIOR POLICY STATEMENT**

The YMCA reserves the right to warn, suspend, or dismiss any program participant or member from our programs and facilities upon the following conditions:

- ◆ If their behavior poses a threat to themselves or others.
- ◆ If they require an inordinate amount of attention from the staff thereby causing inadequate levels of supervision for the remainder of the participants or members.
- ◆ If their behavior is determined to be inappropriate within the scope and spirit of the YMCA values.
- ◆ For any reason within the discretion of YMCA management.

## **DISCIPLINE POLCY**

## YMCA DISCIPLINE POLICY (cont.)

- ◆ Abusive language, mishandling of equipment, or defacing of property will not be allowed.
- ◆ Food, water, or use of toilets will never be denied or used as discipline.
- ◆ Brief, supervised separation from the group will be the primary form of discipline. No child will be placed alone or locked in a room.
- ◆ Children must walk and keep their hands and feet to themselves.
- ◆ Any child that willfully disobeys any rules, policies, or procedures of the YMCA is subject to immediate suspension and/or dismissal from the program by the Site Director and/or YMCA Program Director.

In the event that suspension or dismissal is deemed necessary at the discretion of the Site Director and/or YMCA Program Director, the parents will be notified personally. The day of such action will be the last day that the child is allowed to attend. When talking to a child who is being corrected the staff will use the words, "disciplined" instead of "punishment". Punishment implies "getting even" whereas "discipline" is instruction and training of the mind, body and moral faculties. (Webster)

## Registration Procedures

### How and where?

Parents must register their child at local YMCA by noon of the start date. Registration will ONLY be accepted at the Frisco, Russell Creek or Legacy YMCA Branches\*

\*If attending Anderson, Borchardt, Riddle, Taylor Elementaries, or Plano ISD schools please sign up at the Russell Creek or Plano YMCA in Legacy YMCA's

**Staff members at After School sites CANNOT take registrations.**

### What do I need to fill out?

At each sign up a registration form and payment contract MUST be filled out completely. The membership, registration, and prorated fees are due at sign up.

### Immunization requirements

Each program participant must have a recent immunization record on file at the school he/she attends.

### How much does it cost?

Refer to the After School Rate list on the back of this handbook.

## **Billing Policy and Procedures**

### **Billing Options**

You may choose your monthly billing upon signing up for after school care.

#### **Statement Billing:**

Payments may be made either monthly on the 1st or 15th or semi-monthly, 1st and 15th. Bills will be sent to the after school location one week prior to the due date. You will be asked to SIGN for your bill. If for some reason you do not receive a bill you may get one in the mail. There is a \$25 late fee per child for late payments. A \$25 returned check fee will be assessed to all returned checks.

#### **Drafts:**

Drafts may be set up either monthly on the 1st or 15th or bi-monthly, 1st and 15th on a Visa, MasterCard, American Express, or Checking account. There is a \$25 returned draft fee for all returned drafts. There is a 30-day cancellation notice to cancel the draft option.

### **Making a payment**

Payments may be made at the After School site, by phone, mail, or made at your local branch. Staff at the site will provide you with a written receipt. Please keep these for your records.

### **Making Billing Changes**

**All changes to After School care attendance or billing preferences must be made in writing.** You may obtain a cancellation/change form at the site or online at [www.friscoymca.org](http://www.friscoymca.org), [www.russelcreekyymca.org](http://www.russelcreekyymca.org) or [www.planoyymca.org](http://www.planoyymca.org). To find out the appropriate contact branch, please refer to the back page of this handbook.

### **Cancellation**

**All cancellations must be made in writing. The YMCA requires a 7-day cancellation notice.** Please obtain a cancellation/change form at the site or online at [www.friscoymca.org](http://www.friscoymca.org), [www.russellyymca.org](http://www.russellyymca.org) and [www.planoyymca.org](http://www.planoyymca.org).

## Billing Policy and Procedures Cont.

### NO SHOW/NO CALL POLICY

The YMCA reserves the right to drop your registration from the program if your child is more than 2 weeks absent (10 days) of care without notification. Please notify the YMCA if your child will be absent for an extended period of time. YOU are responsible for any fees due to the YMCA up until the last day of care.

### **Billing Questions**

After School staff members are not familiar with billing procedures. If you have any questions regarding your bill and/or program changes please call your local YMCA and ask to speak to the After School Financial Director. Please refer to the back page for the correct contact information.

### **DROPS/COLLECTIONS/NONPAYMENT**

Please make sure to keep your account up to date. If you currently have a balance with the YMCA in any programs you may not be able to sign up for additional programs until the balances are paid. **Members with account balances 30 days or more past due will be dropped from the program. Accounts with balances 45 days or more past due will be sent to collections.**

## Other Fees and info

### Unexcused Absence Fee

Parents should call and notify staff that their child will be absent for after school care. You may leave a message on the site phone with your name, phone number, and driver's license number. **A \$3 fee will be assessed to your account for every unexcused absence. A \$5 fee will be assessed if your child rides a bus route.**

### Late Pick Up Fee

There is a \$1 a minute per child fee for every minute after 6:30pm. Late pick up fees must be paid upon pick up THAT day. If payment is not made it will be assessed to your account. If you are continually tardy, it may result in suspension from the program.

### Vacation Week

There are no discounts for absences, however, you are allotted one vacation week per semester per child if your child is not present for one week of care. Please call the YMCA for more information.

### Tax Information

Please retain all payment receipts if necessary for filing your income tax return. A print out of year to date payments may be available to you after January 15, 2010 **upon request**. Please allow 10 days to process request.
